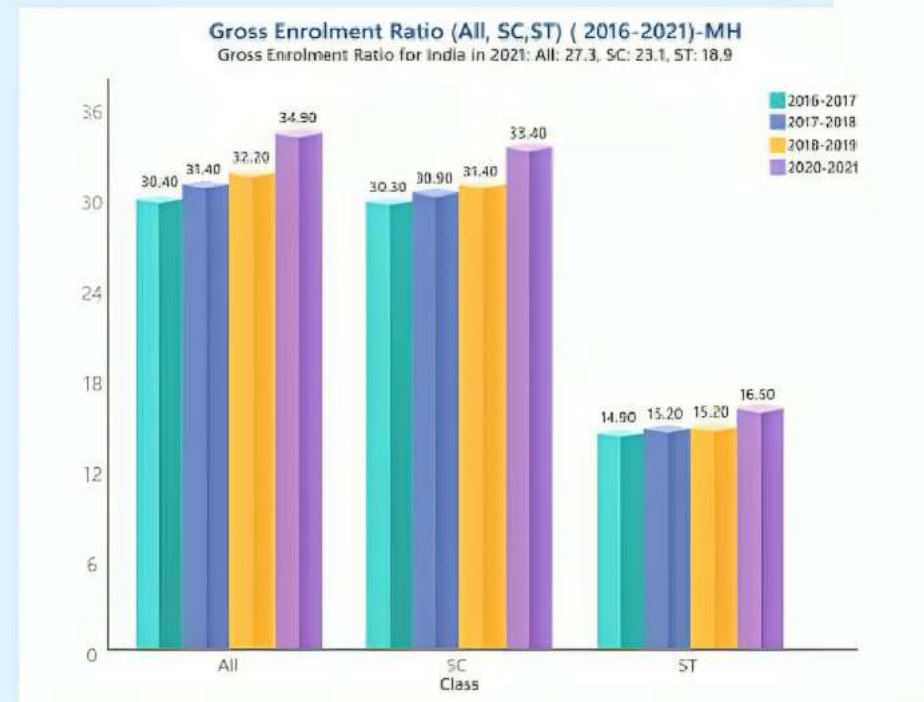

ME & MY NEP

Maharashtra's higher education sector is one of the biggest in the country. The state has a grand vision for its education. One of the key pillars in achieving this vision is the collaboration and active participation of universities in higher education. Universities also play a vital role in implementing government initiatives like the National Education Policy (NEP), fostering academic reforms, and adapting to changing educational paradigms.



In December 2022, the state government formed the NEP Steering Committee, which continues to engage the various universities and colleges and handhold them in their efforts. Over the last eight months, the committee has deliberated and consulted thousands of students, principals, teachers, and directors of various higher education institutions of the state and inspired them.

The government also established the Maharashtra State Faculty Development Academy (MSFDA) in 2019, which is undertaking pioneering work in faculty training and educational programmes across the state by imparting innovative and advanced pedagogical tools.

How is NEP being implemented?

The essence of a policy lies in its implementation. The government of Maharashtra has made extraordinary efforts to implement NEP through extensive consultation with Stakeholders.

The process started with the formation of the Mashelkar Committee. The Government of Maharashtra established a Task Force under the chairmanship of Dr. Raghunath Mashelkar, Ex-Director General of the Council of Scientific and Industrial Research, New Delhi, to study the New Education Policy (NEP) and recommend its implementation in the State of Maharashtra.

The Committee devised the Plan of Action for NEP implementation and submitted its Report in June 2021. The Report was accepted by the state government and approved the formation of five sub-committees to study and determine the implementation strategy for various policy reforms of NEP 2020. These sub-committee have submitted their reports.
