NOTIFICATION

MAHARASHTRA UNAIDED PRIVATE PROFESSIONAL EDUCATIONAL INSTITUTIONS (REGULATION OF ADMISSIONS AND FEES) ACT, 2015.

No. Misc.2015/CR 457/TE-4.— In exercise of the powers conferred by sub-section (5) of section 8 read with section 12 of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 (Mah. XXVIII of 2015), the Government of Maharashtra hereby notify the salary and allowances to be paid to the Chairperson of the Admissions Regulating Authority and Fees Regulating Authority and allowances to be paid to the Members of the said Authorities, namely :—

1. The salary of the Chairperson of the Admission Regulating Authority and Fees Regulating Authority shall be,—

(a) in case of retired Judge of High Court equal to the salary of the Judge of the High Court ;

(b) in case of retired officer of the Government of the rank of the Chief Secretary equal to the salary of the Chief Secretary :

Provided that, if the Chairperson at the time of his appointment is in receipt of or has received or has become entitled to retirement benefits by way of pension or gratuity employers contribution to the Contributory Provident Fund or other forms of retirement benefits, the pay shall be reduced by the gross amount of pension or pension equivalent to service gratuity or employers contribution to the Contributory Provident Fund or any other form of retirement benefits, if any, but excluding pension equivalent to retirement gratuity, drawn or to be drawn by him.

2. Chairperson of the Admissions Regulating Authority and Fees Regulating Authority shall be entitled to vehicle and following allowances, namely :—

(a) Daily allowance and Travelling allowance while on tour as admissible to All India Services officers ;

(b) Compensatory allowance as admissible to All India Services officers.

3. Members of the Admissions Regulating Authority and Fees Regulating Authority shall be entitled Dearness allowance and Travelling allowance as admissible to All India Services officers to following allowances, namely :—

(a) Meeting attendance allowance at the rate of Rs. 5000 per meeting.

4. The Chairperson of the Admissions Regulating Authority and Fees Regulating Authority shall be entitled to the salary and allowances from the day of on which he assumes the office.

5. The Members of the Admissions Regulating Authority and Fees Regulating Authority shall be entitled to the allowances from the day of publication of the Act.
